• Eligibility for selection of Collecting Sarkar:-*a)*The candidates shall be of age not more than 45 years & not less than 18 years on the 1<sup>st</sup> day of January in the year of 2017.*b)* The candidate must be a citizen of India as defined in part-II of the Constitution of India & must have passed the final examination of Class VIII from any recognized institution. *c)* Should have rendered satisfactory service as Collecting Sarkar for at least 6(Six) years in any Gram Panchayat under the jurisdiction of this district.

• The eligible candidate who fulfill the above condition may apply for the said selection process. In this respect a prescribed application format is enclosed herewith. The duly filled up application through the respective Block Development Officer should be reached to this Office on or before **15/05/2017**.
