The Said tender will be opened at 4:30 P.M. in this office on 27/01/2020. Estimated turnover of hire charge for dry vehicle per annum Rs. 1.00 Lakh (approx).

TERMS AND CONDITIONS

1. Max permissible amount is Rs. 17000/- per month inclusive of hire charge, cost of Fuel and Lubricant and applicable Taxes on the basis of nos. of engaged working days and actual millage coverage in a month.
2. Rate must be quoted in Rupees in figure for hire charge plus claim of GST charge separately per working day avoiding over writing.
3. Fuel and Lubricant cost will primarily be bear by the Vehicle Owner which will be re-imbursed in first week of succeeding month against submission bill alongwith cash memo for existing rate of Fuel & Lubricant.
4. Permitted limit for rate of Fuel consumption for 12 KM per litre Diesel and 500 KM per Litre Mobil are fixed.
5. Marked Sealed Quotations accompanied with self attested copy of valid PAN Card, Driving Licence, Rout Permit, Road Tax clearance certificate, Blue Book of Car, Pollution Control Certificate, Insurance Coverage, Fitness certificate must be reached in this office within 2.00 P.M. of 27/01/2020. In case firm, submission of valid trade licence, P.T.C., GST Regn. With self attestation must be submitted alongwith rate Quotation.
6. Payment will be made on monthly through A/C payee Cheque after deducting the applicable taxes against submission of bill (In duplicate) separately for hire charge and Fuel consumption cost respectively.

Security money for an amount of Rs. 2000=00 (Rupees Two Thousand) must be deposited by the successful Quotationer within Seven days from the date of issue of work order which is refundable on termination of contract period. The contract period generally being for one year from the date of issue of work order; it may be extended for further period with approval of approving authority.
8. Haltage of Deiver & Demurrage, Accidental risk, repairing cost etc. of vehicle will not bear by the Corporation. If the successful Quotationer has failed to place vehicle within 3 hrs of instruction, the authority will hire vehicle from open market at per market rate and said payment will be deducted from the bill of successful Quotationer.
9. For extra time work beyond 10 hrs duty Tiffin allowance will be allowed to Driver as per rate of existing G.O. of Transport Authority on monthly basis during bill payment.
