**1. Invitation to Expression of Interest (EOI)**

**1.1 Invitation**

District Project Office, Samagra Shiksha Aviyan, Jalpaiguri (**herein after called DPO, SSA, Jalpaiguri**) is under Department of School Education, Govt. of West Bengal.

The Office needs a experienced & competent Non Government Organisation (**herein after called NGO**) having expertise and good track record in the field of disability area , particularly and specifically on dealing children with visual impairment, corrective surgery, hearing impairment, hearing aid repairing, ear mould fabrication, sign language training, extension of therapy support and also expected to be tapped and utilized at grass root level.

**DPO, SSA, Jalpaiguri** invites Expression of Interest (**EOI**) from NGOs with experience in successfully executing similar projects. **Preference may be given to NGOs situated within North Bengal.**

This EOI document indicates the scope of work, qualifying requirements, forms and procedure for submission of proposal for interested Organizations. The selection of the successful bidder among the short listed ones shall be based on technical and financial criteria, with 70% weightage for technical competency/capability and 30% weightage for financial proposal.

**DPO, SSA, Jalpaiguri** reserves the right to accept or reject any or all the offers at any stage of the process without assigning any reasons thereof and no claim/dispute on this aspect shall be entertained.

**DPO, SSA, Jalpaiguri** approach for Selection of a suitable NGOs for providing support to CWSN Students.

The selected NGO/(s) shall provide all kind of support such as Extension Therapeutic Support Services, Identification and assessment of children with visual impairment (through Camps), extension of Micro interventional support service to children with hearing impairment including minor repairing of hearing aids, orientation of teachers on sign language etc.

Apart from the above, it shall also include additional activities which is co-related with main activities and time to time by the undersigned.

**SELECTION METHOD:**

- Stage I : On line Technical Evaluation
- Stage II : Request For Proposal Form (RFP) Evaluation and Financial Evaluation
- Stage III : Selection of NGOs by the District Level Committee
- Stage IV : Panel of NGOs to be approved by the State Level Authority

## Stage I: Technical Evaluation

1. The DPO, SSM, Jalpaiguri needs a experienced & competent Non Government Organisation having expertise and good track record in the field of disability area, particularly and specifically on dealing children with visual impairment, corrective surgery, hearing impairment, hearing aid repairing, ear mould fabrication, sign language training, extension of therapy support and also expected to be tapped and utilized at grass root level. (Details enclosed separately)
2. The DPO, SSM, Jalpaiguri shall evaluate only those organizations who fulfill the following criteria:
  - i. The applicant shall be a Registered Society under Societies Registration Act 1961 (Copy of valid registration certificate to be enclosed)
  - ii. Registration no of the NGO registered under PWD Act (Person with disabilities Act) 1995 (Copy of valid registration certificate to be enclosed)
  - iii. Details about working experience in disability field (Copy of Supportive documents showing working experience in disability field at least for five years in disability field to be enclosed)
  - iv. Details about working experience with SSA activities (if any, documents to be attached).
  - v. Whether the organization runs in its own/rented building.
  - vi. Details of staff working mentioning professional qualification and experience against each.
  - vii. Documents –
    - a) Annual report including audited accounts for last three years.
    - b) Constitution/By – laws of the organization.
    - c) Constitution of Board Management and the particulars of each member.
    - d) Copy of PAN Card of the organization.
  - viii) An amount of Rs.25,000 (Rupees twenty five thousand only) need to be deposited in favour of District Project Officer, SSM, Jalpaiguri as per the mandate of the [wbenders.gov.in](http://wbenders.gov.in) through online EMD Payment.
