2. Copies of latest Trade Licence, PAN Card, GST Registration , Identity Prove have to be attached.
3. Tenderers should be submitted in sealed envelope super scribed with " Tender for Hire vehicle for District Social Welfare Department., Jalpaiguri " in the Box kept in the Pool Section, 1st Floor, Sadar SDO's Office, Jalpaiguri.
4. In the main envelop, there should be two separate envelopes containing the documents associated with the technical bids. Only when an agency qualifies in the technical bids, will his candidature for financial bid be taken into consideration.
5. On the day of opening of the tender, the tenderers must be present with specimen copies of the terms for which the rates were quoted.
6. Prospective tenderers must be ready to place vehicle/ vehicle within 7 days from the date of acceptance of the offer letter as well as taxi permit for the particular vehicle shall have to be produced within 60 (Sixty) days from the date of issue of acceptance offer letter, otherwise order will be treated as cancelled automatically.

Any other information will be available from the D.M. Pool Section, Jalpaiguri. The undersigned reserves the right to accept any rate at his discretion.

The undersigned does not bind himself to accept the lowest rate of tender and may be use discretion in accepting higher than the lowest rate with a view to ensuring condition of the vehicle.
