## Specification of each Signboard:

- 1. Size of the Board 4ft. X 3ft.;
- 2. a) Frame Made with MS Flat Patti of 4mm X 16mm (two pieces 4ft. and three pieces 3ft.) making holes, drills and fitted by welding with MS Sheet of 26 gauge;
  - b) MS Sheet of 26 gauge should be fitted on the above frame by welding and making necessary holes by drill for fitting the board on the wall with nails / screws;
  - c) Latex vinyl of best quality with necessary printing of the materials to be provided by the tenderer should be pasted on the board as fabricated. Aluminium bit on the edges with corner capping should be fitted with screws to make the matter beautiful and durable;
- 3. Photograph of the Signboard may be seen as kept in this office.

Per sq. ft. rate complete in all respect including cost of carrying and installation may be quoted.
