The Judgeship of Jalpaiguri will not take any responsibility for delay, loss or non-receipts of quotation sent by post / courier.
2. Rates quoted should be inclusive of all applicable charges, taxes, duties and levies.
3. Conditional quotations will not be considered.
4. Willing suppliers submitting quotations should specify the address of its office and its phone / Mobile number for the purpose of quick communication in the event of urgency.

The Judgeship of Jalpaiguri may award the contract to the supplier whose quotation has been determined to be substantially responsive and who has quoted the lowest evaluated price. However, The Judgeship of Jalpaiguri is not bound to accept the lowest bid.
